



- (3) Lee B. Thomas, Route 2, Box 346, Eugene, Oregon. Farm consists of 12 acres of the original Johnathan and Jeanette Thomas Donation Land Claim in Section 33, Township 16 South, Range 3 West of the Willamette Meridian, Lane County, Oregon.
