I, Lowell D. Baker being first duly sworn on oath do depose and say,

That I am over the age of 21 years, to-wit: 32 years, of sound mind and memory, and that I make this affidavit of my own free will and of my own knowledge for the purpose of proving ownership of a certain farm located in Clackamas County and State of Oregon, and being a portion of the following:

The North one-half of the north one-half and Lots One, Two, Three and Four of Section 21, T. 3 S. R. 1 W. of W.M.

That originally 320 acres of land was owned by Endymian Baker and Sarah Jane Baker, husband and wife, who were my Great grand parents, that they acquired this land from the United States Government in the year 1853, and held same by virtue of a Patent recorded December 18, 1875 in Book "I" at Page 398 of Deed Records of Clackamas County and State of Oregon, that a portion of said land was handed down to Allison Baker and Florence Baker, husband and wife, my Grand parents; that the deed to said Allison Baker et ux is recorded in Book "Y" at Page 245 of Deed Records of Clackamas County, State of Oregon;

That without ever having been transferred to anyone other than a direct decendant of said Bakers, this portion ultimately was deeded to me by deed recorded on the 5 day of Sept., 1951, and that I presently live thereon and farm same having done so since the time of the transfer to my name, that the said deed is recorded in Book 448 at Page 281 of Deed Records of Clackamas County, State of Oregon, and that there now remains 20 acres in said parcel in my name.

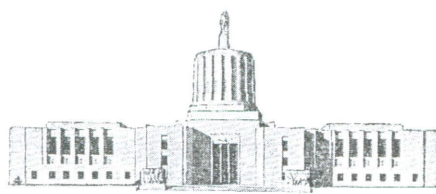
