Diles Daugherty purchased this 320 acre form from Robert Hull on June 9, 1864 for the sum of Five Hundred dollars. Diles Daugherty and Odely (Doke) Daugherty were matives of Virgenia, moving to Pike County Illinois where he was a blacks mith and farmer. In 1852 he crossed the plains with sume children. His wife died on the trip, and he later remarried twice , He settled on a donation land Claim in Pack County, living there a few years eventually moved to a farm near Hubbard, then moving to this farm at molalla. Siles son Charley was next to farm the land. He married mary Sawtell and they had five sons. Fiel the youngest took aver the farmafter his father's death. at present the form consists of 187 acres Owned and operated by a great Grandson, Charles a great deal of grain, seeds, and all kindsog Daugherty. livestack have been raised on this farm. at present the postures are sown to grase. Sheepand Beef are raised as well as some Dairy Cattle.
