We rent, ^{irrigated} pasture every year, but not the farm.

Kaspar Kubli sold the farm to Henry Kubli. My father, Henry Kubli, was born on the ranch in 1860. He (Henry) died in 1910. And left the ranch to my self and three brothers. My mother (Maud Kubli) had a life lease on the ranch and she operated it until her death in 1952 April 1. This is all recorded.

The ranch was divided in 1952. My husband and I took bare land. We built a home a barn a shop, a shed a Care taker's house and put in all crops.

We have the original sale of ditch and water right date 1869. Paid for by Kaspar Kubli \$2000.00 in "gold coin"
