In order to qualify for the Century Farm Program I wish to make a statement of the following facts concerning my grandfather David Mosby, and the family ownership of his claim.

David Mosby came to Oregon from Pettis County, Missouri in 1850 with an elder sister Nancy and her husband Henry Small, They made their first stop at Brownsville, Oregon, and it was here that David Mosby acquired a band of mules, and managed a mule pack train, packing supplies from Brownsville, Oregon to Yreka, California for the Gold Miners. In 1852 he settled on his land claim three miles east of what is now Cottage Grove, Oregon, which has been owned, farmed and managed by the Mosby family continously for the past 106 years. Mosby Creek in this locality was named for David Mosby, and at the time of his death in 1892 he was one of, the twenty largest tax payers in Lane County.

After the death of David Mosby, my father Robrt Henry Mosby became the owner of a portion of the land claim, where he was born in 1867, lived, farmed and managed his farm untill the time of his death in 1940, at this time I became the owner of a portion of the Mosby land claim amounting to 38.72 acres which is located in Sec. 36 T. 20, S. R. 3 W. W. M. and Sec. 1 T. 21 S. R. 3 W. W. M. Lane County, Oregon.

I also own a portion of the Mosby land claim amounting 79.97 acreswhich was inherited by one of my brothers George Small Mosby in 1940, and which became my property in 1947, and which is located in Sec. 36, T. 20, S. R. 3 W. W. M. and Sec. 31, T. 20, S. R. 2, W. W. M.


