I further swear that I heired the 7.5 acres that I now possess from my mother, Lola A. Burkhart, who died March 14, 1955. She being a direct heir of Isaac R. Froman and Eliza Jane Froman.

I further state upon oath that I am operating said farm and have continued to operate said farm continually, since the same has been acquired by me, from my mother, Lola A. Burkhart, who was a direct descendant of Isaac R. Froman and Eliza Jane Froman, and it has been continually in our family possession for more than 100 years.

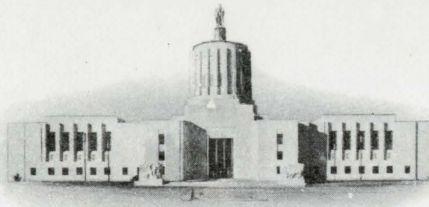
