I, Janet C. Herrling, being first duly sworn, depose and say:

That I am 52 years of age; that I was born October 21, 1905; that I am a great-granddaughter of Vineyard C. Brock; that Vineyard C. Brock filed for his Donation Land Claim No. 2044, June 22, 1854, and received the patent in 1865; that said D.L.C. is situated in Township 13 South, Range 3 West of the Willamette Meridian in Linn County, Oregon, which place is situated along the Calapooia River one and one-half miles northeast of Shedd, in Linn County, Oregon;

That my grandfather and my grandmother lived on said D.L.C. until their death and each of their deaths; that my great-grandfather, Vineyard C. Brock, died when he was 40 years of age, and is buried at the Riverside Cemetery in Albany, Oregon;

That my grandfather Steward P. Brock and his wife, Janet S. Brock, who is my grandmother, lived on the farm until the death of Steward P. Brock in 1929, and my grandmother lived there until her death in 1936, and that my mother, Mary A. Arnold, was a daughter of Steward P. Brock and lived on said farm until her death in 1952;

That I have owned the portion of the farm that my father and mother owned since 1952, the death of my mother's death, and I am still living on said farm;

That the portion of land from said D.L.C. is now 209 acres, which has been in the name of Vineyard C. Brock and his descendants from 1854 to the present time.

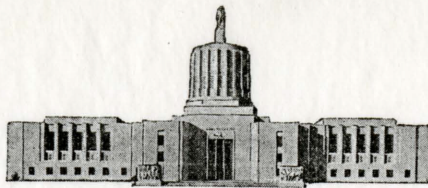
