The N. $\frac{1}{2}$ of the N.E. $\frac{1}{4}$ of Sec. 9 and the N. $\frac{1}{2}$ of the N.W. $\frac{1}{2}$ of Sec. 10, T. 13 S.R. 3W, prior to December 1850.

We further swear that upon the death of Miller Morgan Mar 3, 1901, Joseph William Morgan, our father, heired a portion of this D.L.C.

We further swear that upon the death of Joseph William Morgan, our father, on Feb. 10, 1935, we E.F. Morgan and Lottie Morgan, brother and sister, heired a portion of the original D.L.C. This portion being in T. 13 S. 4 lands 3 in Range 3 West, consisting of 308.66 acres.

We, E. F. Morgan and Lottie Morgan further swear that this property has been in the family possession continuously for more than 100 years.

We further state upon oath that we own and manage this portion of the original D.L.C. together.
