I, Ralph R. Robnett, being over the age of 21 years, and in every way competent to make this affidavit and being first duly sworn, depose and say, that my grandfather, William Robnett, in the year September 1848, settled on a Donation Land Claim about one mile east of the present town of Crawfordsville. This claim of 639.29 acres was located in T. 14 S.R. 1 W., Sec. 8-9-16 and 17. The Donation Land Claim certificate was No. 2569.

I further swear upon oath that William Robnett, my grandfather, died April 3, 1886. At his death this property was heired by his wife, HannahPowell Robnett, my grandmother Hannah Powell Robnett, the wife of William Robnett, died January 2, 1893.

Before the death of Hannah Powell Robnett, she deeded this property, described above, to D. F. Robnett, my father.

I further swear upon oath, that D.F. Robnett was my father and he died March 15, 1931. Before his death, he deeded to me, Ralph R. Robnett, 127 acres of the above described Donation Land Claim. When I, Ralph R. Robnett, became in possession of this property, I deeded one acre of the original 127 acres to another party, and the State of Oregon has since taken for road purposes two acres, which leaves me at the present time 124 acres.

I further swear upon oath, that of the 124 acres of said original Donation Land Claim, I am now and have continually operated said farm since I became in possession of the same.
