## JEFFERSON HAS ANOTHER

The Herbert Looneys this week report a portion of their farm, north of town has been in continuous family ownership for more than a century. It is 108 acres of the original donation land claim taken by Looney's great grandparents, Jesse and Ruby bond Looney, and approved Sept. 27, 1850. The claim was No. 53, and approval certificate was No. 705.

The land lies on the north side of Looney's farm, and grows wheat, rye grass, barley and sometimes peas.

The Looney family originally came to Oregon in 1843.
