Rickreall Family nored at Fair

A Rickreall family, who still operates a farm their ancestors settled more than a century ago, will be among 37 such

families in the state honored at the Oregon State Fair Friday, August 31.

The farm is owned by Mr. and Mrs. Robert Farmer, Route 1, Box 184E and was founded by great-grandfather John Farmer in 1868.

The program, cosponsored by the Oregon Department of Agriculture and the Oregon Historical Society cooperation with the Oregon State Fair, is to be on the concert stage starting at 11:30 a.m.

The Century Farm program was started in 1958 by the cosponsors and was held yearly through 1960 when it was placed on a five-year basis. This year is being held as a special feature of the Historical Society's 100th. anniversary.
