

Century 5064 Farmers

The John Donaldson family of Tillamook is one of thirty-seven elite Oregon families. The Donaldson's plot is one of thirty-seven historic farms in the state that were settled a century or more ago and are still operated by ancestors today. This select group of Oregon Century Farms were honored at a special program Friday, August 31, at the Oregon State Fair. The program was in observance of the Oregon Historical Society's hundredth anniversary.

Seventeen Oregon counties represented by the 37 Century Farmers. The Donaldsons are Tillamook County's only Century Farmers. Their historic farm is located at 130 Donaldson Road in Tillamook. It was founded by John Donaldson's grandfather, Joseph C. Donaldson in 1864.
