John W. and Olive Mulloy, Hillsboro Route 4, Box 201, will be among the 37 Oregon families to be honored as new century farm owners at the special program Friday, Aug. 31 at the Oregon State Fair in Salem.

The Mulloy farm was founded by Mulloy's grandfather, Alfred D. Mulloy, in 1872.

The program of recognition of century farms is co-sponsored by the Oregon Department of Agriculture and the Oregon Historical Society in cooperation with the Oregon State Fair. The event will start at 11:30 a.m. on the concert stage at the fair.

Started in 1958, the event was held yearly through 1960, then placed on a five-year basis. However, this year is being held as a special feature of the Oregon Historical Society's hundredth anniversary observance.
