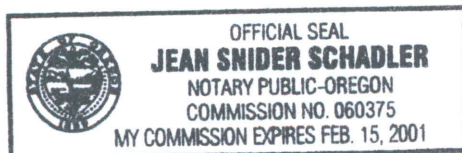

The CRUMP RANCH (1895 - 1995)

Thomas A. Crump Sr. (1854-1939) and his young wife Johanna homesteaded the original Crump Ranch in early 1895 in Warner Valley on the shores of 'Christmas Lake', later renamed Crump Lake. In 1900, they purchased an additional 160 acres in Adel and moved their residence four miles south to the current ranch headquarters location. It has been said this move was to locate closer to the Adel school for their young children, and to have access to the high quality Deep Creek water for irrigation. The original ranch house (1900) surrounded by popular trees remains at this location

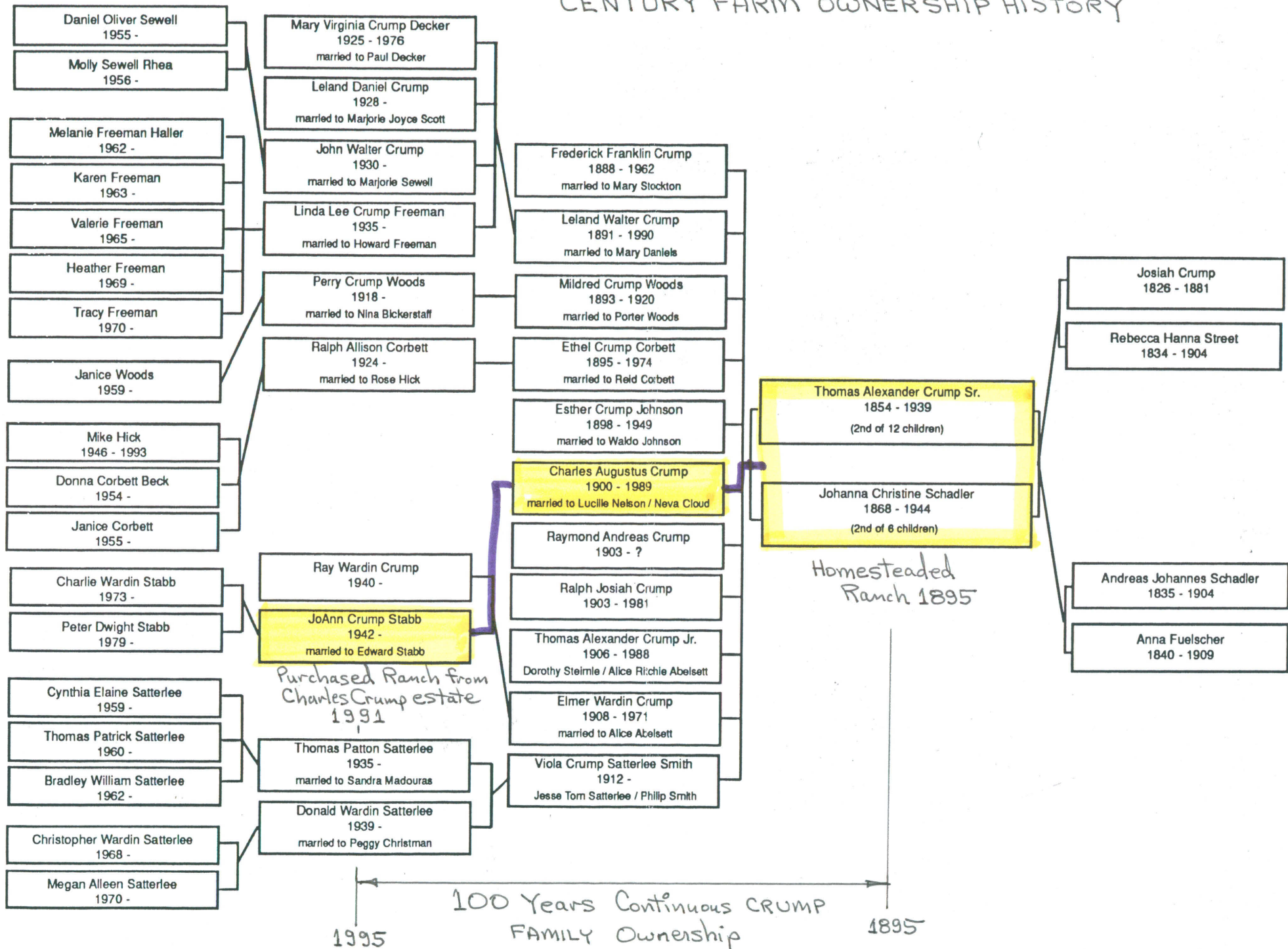
They had eleven children, two of whom continued in the ranching business (Leland and Charlie), while several of the younger ones went on to earn degrees at Oregon State University (Tom Jr., Elmer Wardin and Viola) and to pursue other careers.

The Crump Ranch has been continuously engaged in stock raising including sheep, cattle, and horses. Charles Crump (1900-89) continued to run the ranch in 1919 when Thomas Sr. retired to Lakeview. He became legendary for "Charlie's Way of Doing Things" and spent considerable effort at reclaiming the land. One famous moment came in 1959 when a geothermal geyser erupted as a result of exploratory drilling at area near the southwest corner of Crump Lake. It spouted continuously for almost one year and was a major Lake County tourist attraction. Charlie married Neva Cloud in 1970.

Charlie and Neva continued to raise cattle until his death in 1989. Neva sold the Crump Ranch to Ed and JoAnn Crump Stabb (Charlie Crump's niece and daughter of Elmer Wardin Crump) in 1991. In 1992, Ed and JoAnn purchased a portion of the adjoining M C Ranch and expanded the Crump Ranch holdings to over 7,000 acres of deeded and leased land. They have continued to restore and improve the Ranch, and are currently growing 1,500 acres of barley, oats and peas, and a hay crop. Additionally, they operate a commercial and registered Angus cow-calf herd of over 300 head at this writing, July 1995.

Crump Ranch plans centennial celebration

The 100th anniversary of the Crump Ranch in Warner Valley will be celebrated during the July Fourth weekend at a "Friends and Family" barbecue in Adel.

The celebration will be Sunday, July 2 from noon to 5 p.m.

The ranch was homesteaded in 1895 on the southwest corner of Crump Lake by Thomas A. and Johanna Schadler Crump, who moved from Fort Bidwell, Calif.

Originally from Germany and England, the Crumps settled in Oregon in the 1880s. They raised a family of 11 children at the homestead raising sheep and cattle and operating a summer haying crew.

Crump Ranch is currently owned and operated by third-generation family members Jo Ann Crump Stabb, daughter of Elmer Wardin Crump and granddaughter of Thomas A. Crump, and her husband Ed Stabb, and cousins Marge and John Crump, son of Leland Crump, who was 4 years old when the family moved to the homestead.

Jo Ann Crump Stabb and her husband purchased the ranch in 1991 from Neva Crump, wid-

ow of Jo Ann's uncle Charles Crump. Charles operated the family ranch since acquiring an initial portion in 1919. The ranch continues to be a commercial Angus cow-calf operation and has added integrated farming of barley, oats, peas and hay with the purchase of a portion of the MC Ranch in 1992.

"This is a wonderful opportunity to celebrate the legacy of the original Crumps who dedicated their lives to Warner Valley, enabling it to become a productive ranching area," said Jo Ann Crump Stabb of the celebration. "We are trying to carry on the Crump tradition and maintain strong ties to Oregon agriculture."

Charlie Crump ran the ranch operation for 70 years before he died in 1989. He was known for his tireless efforts of improving the land. During the 1930s Charlie owned and operated the Adel Store.

He actively served his community as a member of the Lake County Grange, Farm Bureau, 4-H, Chamber of Commerce and many other organizations. He was honored as Grand Marshal of the Lake County Round-Up.

A highlight at the ranch during the 1950s was

the drilling of a geothermal well that erupted into the 150-foot Crump Geyser in 1959. The geyser erupted continuously for almost one year and spouted as high as Old Faithful.

John Crump, a veteran cowboy who ranched for years in Fields and also worked at the MC Ranch, moved to Adel when the Crump Ranch was purchased in 1991. His vast experience in cattle ranching has enabled the ranch to be restored to full operation with 300 head of cattle.

Ed and Jo Ann's eldest son, Charles, named for his great-uncle Charlie Crump, has spent the last three summers helping rebuild the ranch infrastructure and corrals. He is a senior at U.C.

Davis and is majoring in agricultural economics and communications.

Peter Stabb, younger son of Ed and Jo Ann and a sophomore in high school, has also contributed much time and effort to the ranch projects.

Family members attending the Centennial Celebration include Viola Crump Smith of Mill City, youngest daughter of the original Thomas A. Crump Sr. family; her son Donald Satterlee of Portola Valley, Calif., and his family; Neva Crump, widow of Charlie Crump and previous owner of the ranch; and Alice Crump of Laguna Hills, Calif., widow of Thomas A. Crump Jr. who grew up on the ranch.

Other family members planning to attend are Ralph Cornett of Fullerton, Calif., son of Ethel Crump Corbett, the first child born at the Crump Ranch; Linda Crump Freeman of Texas, daughter of Leland Crump; Dan Crump of Washington, eldest son of Leland Crump; and many of the great grandchildren of the original Crump couple.

Neighbors and friends from Adel, Plush and Lakeview will also join in the celebration.

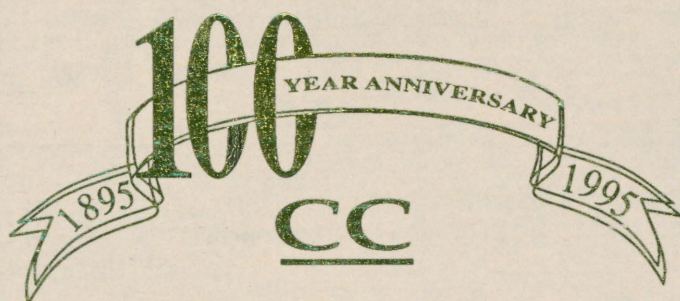

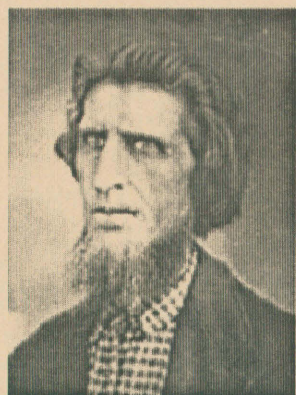
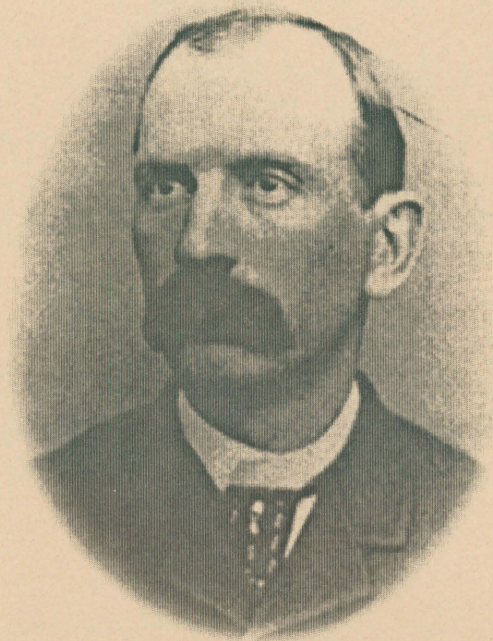

THE CRUMP FAMILY



Josiah Crump, father of Thomas A. Crump Sr. whose family originated in England, was from Kentucky. Rebecca Hanna Street was from New Jersey. They were married in 1852 in Illinois and the first six of their twelve children were born there. They crossed the plains to the Dalles in 1864, and settled in Jackson County, Oregon in 1887. Thomas A. Crump was the second eldest, born 1854.

Thomas A. Crump married Johanna Schadler in 1887 in Fort Bidwell, California, at age 33.



THE SCHADLER FAMILY



Andreas and Anna Fuelscher Schadler of Gluskstadt, Germany, sailed from Homburg on May 19, 1881. They were 13 days adrift and came into Ireland for repairs, and eventually landed in the United States. Johanna Schadler was 13 years old at this time. Her five brothers and sisters included: Frederick, age 15; Wilhelmina ("Minnie"), Age 11, Anna A., Age 8, Mathilda, Age 6, and August, Age 2.

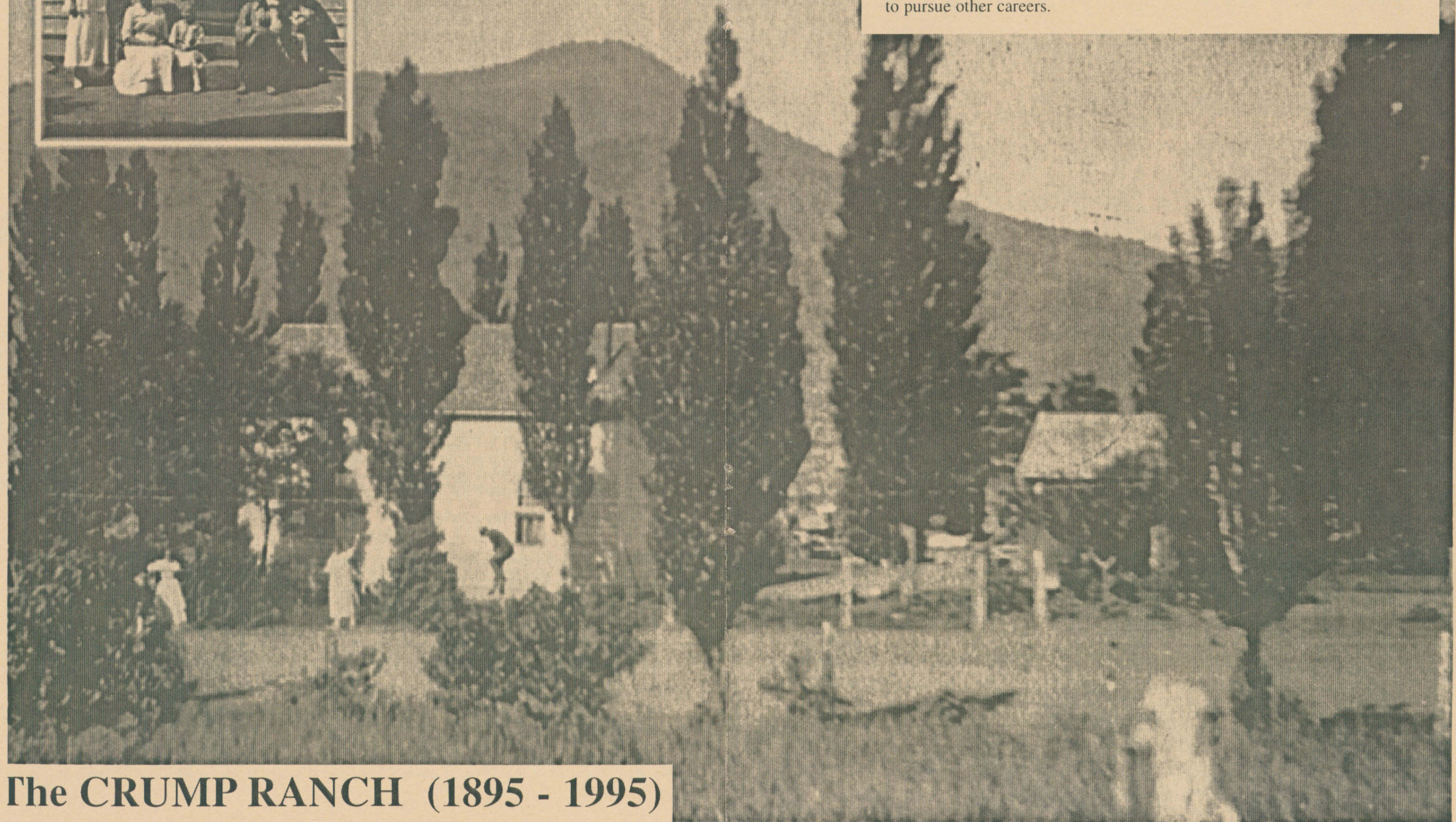
They ultimately arrived in Fort Bidwell, California August 18, 1881, where the brothers, Andreas and Diedrich, made a living as builders and master craftsmen. They built the dias, or pulpit, and the two front doors for the little Church in Fort Bidwell. They were master cabinet makers and built houses and furniture. Andreas moved his family to Reno in 1890, where he continued to build houses and businesses for nearly 15 years until his death in 1904 at age 68.

Johanna Schadler (1868-1944) married Thomas A. Crump Sr. in December 14, 1887, at the age of 19.

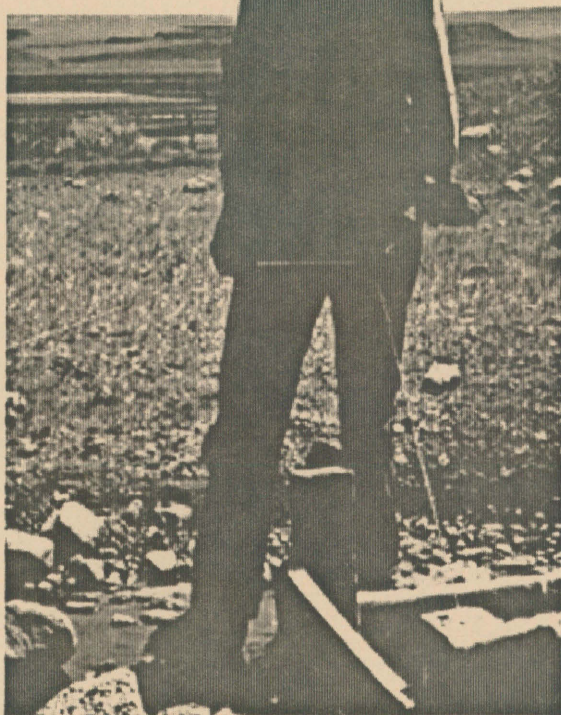
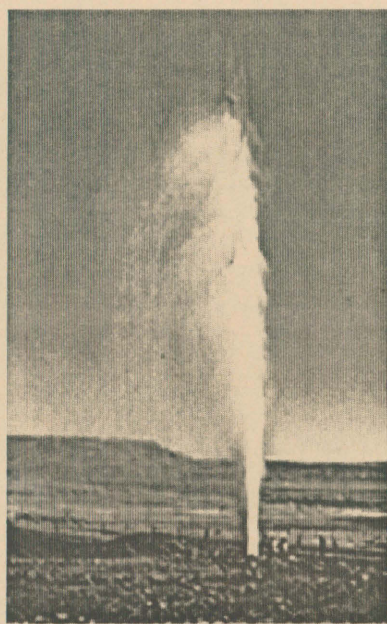

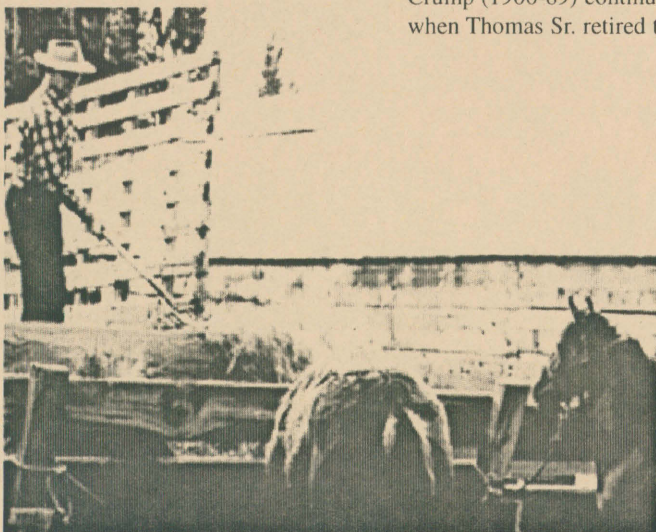

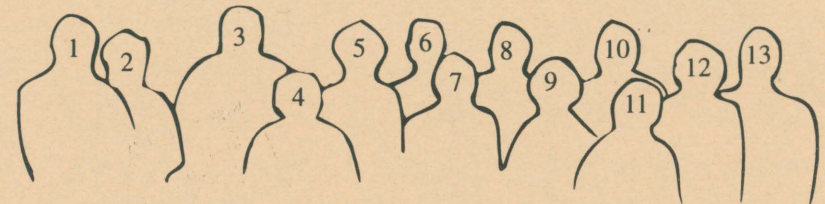

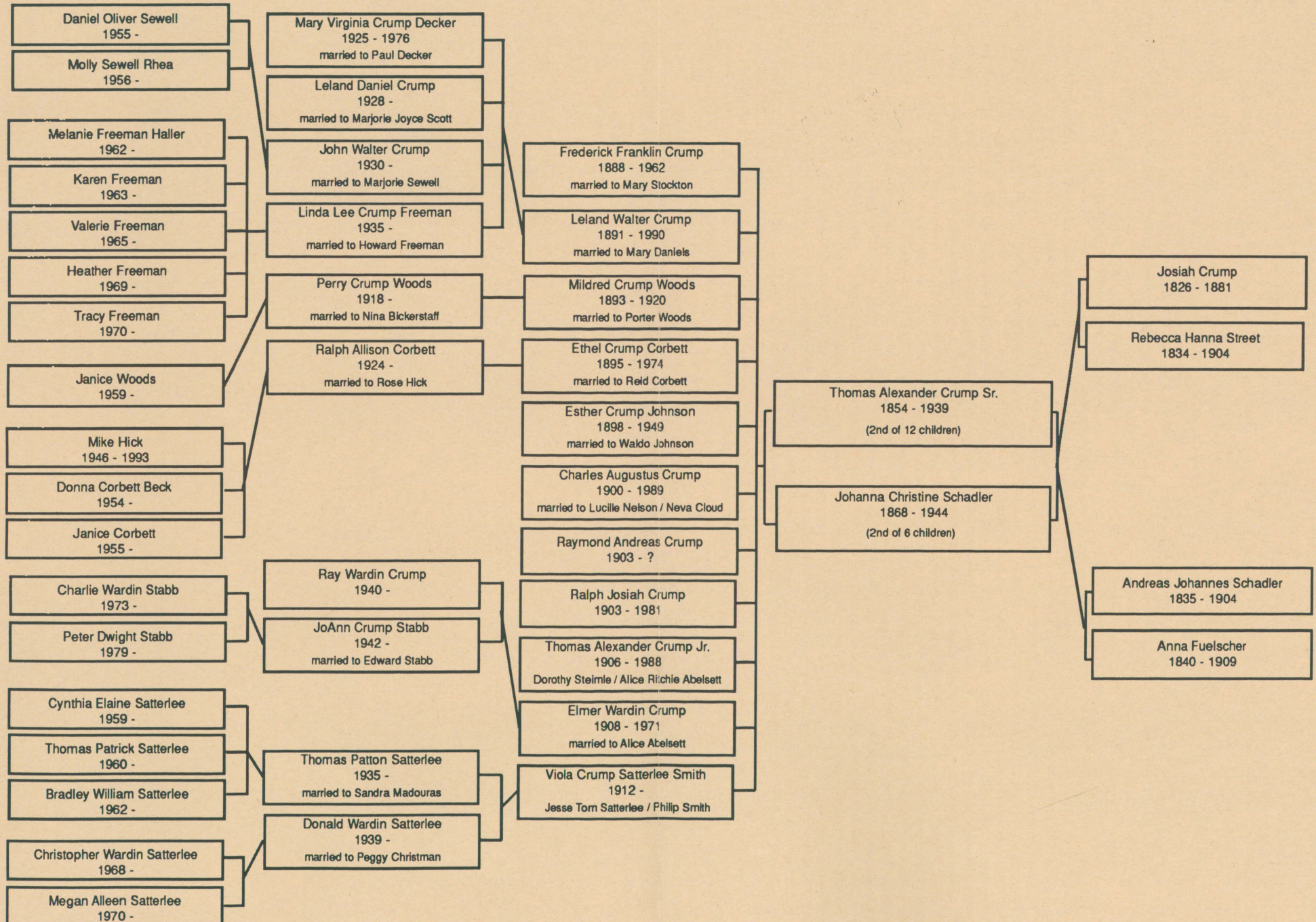
