ember, in the year of our Lord one thousand eight hundred and ninety-eight
Between James F. Adams and Fannie E. Adams, his wife, of Merrill Klamath
County, in the State of Oregon, the parties of the first part, and Fred R. Pope
of the County of Modoc, Modoc County, State of California, the party
of the second part, Witnesses: That the said parties of the first part for and
in consideration of the sum of Three Thousand Dollars, Lawful Money of the
United States of America, to them in hand paid, by the said party of the second
part, the receipt whereof is hereby acknowledged, have granted, bargained
and sold, conveyed and confirmed, and by these presents do grant, bargain and
sell, convey and confirm, unto the said party of the second part, and to his heirs
and assigns forever all those certain lots, pieces or parcels of land, sit-
uate, lying and being in the said County of Klamath, State of Oregon, and
bounded and particularly described as follows, to-wit:

The East half of the East half (E² of E²) of Section Nine (9) the East
half of the North East quarter (E² of NE²) and Lot Number Twelve (12)
of Section Sixteen (16) Township Forty-one South, Range Eleven (11)

TRIBUTE TO THE POPE FAMILY

Angus family, Lynn, Randall, and Leland Pope, have been cattlemen for four generations. In 1870 the first of these four generations, Fred Pope, drove the lead cow of a herd of cattle from Modoc County to Sacramento, California. He had to force the cattle to swim the Sacramento River, because there was no bridge strong enough to hold the herd.

Fred's son, Leland, was born September 23, 1894 at Canby, California. At the age of four he went to Oregon with his parents who had purchased land near Merrill from J. Frank Adams.

"The deed read 265 acres and the boundary went to the river," laughs Leland. "Dad didn't know where the river was because the waters of Tule Lake were flooding 225 of the 265 acres. It was only about a half-mile to the lake shore. I would swim there and hunt ducks. There was no limit to the number killed."

In those days the ranchers in the area ran their cattle together on the range in Northern California between Mt. Dome and the Lava Beds. At branding time there would be six or eight different branding irons in the fire. There were no government regulations.

"No wonder those were the good old days!" says Randall.

"Cattlemen using the range regulated the number of cattle," says Leland. "There was no over-grazing. There was mostly grass on the range; no cheat or bronco grass then.

"There were no veterinarians then. There were only doctors, but there weren't many livestock diseases either."

In the fall of the year cattlemen rounded up two-year old and older steers and drove them to Monatque, California, the nearest rail point. The route taken was via Mt. Dome, over Bald Mountain and then to Shasta Valley. The trip lasted approximately four days and it was a test of survival for both man and cattle.

"Back in those days," Pope adds, "the cows were mostly mixed breeds and all that mattered to the rancher was having calves to sell. Purebred cattle were just starting to show up in the larger herds of the West."

Leland began his education in country schools near his home. He graduated from Merrill High School. He remembers attending the 1910 celebration of the pioneer Czechoslovakians who settled in Malin.

"I ran a greased pig into Tulelake to catch it. I sold that pig for \$5 and it was the most money I had ever made," he says.

In 1915 Leland married Mary I. McGilvray of Canyonville, who was teaching at Merrill Elementary School. She died in 1967. 1939

In October 1930, Leland started raising the black Angus cattle for which Pope Ranches are known today. The first registered Angus were 10 cows and one bull of Congdon and Battles, Rosemere breeding. Of those cows, two are the ancestors of a very large number of cows in the herd today. Registered cows now number about 180, commercials about 125 head. The Popes also raise potatoes, alfalfa hay, and barley — feed and malting varieties and for seed.

In the early 1920's the Forest Service took over the range land and closed out many cattle operations. Today, cattle are run primarily on Bureau of Land Management and deeded land.

Leland remembers that some of the cattle buyers would buy Angus "before anything else." He also remembers that wages were low. He paid his hired man \$18 a month and board. Leland purchased the ranch from his mother in 1935, following the death of his father.

In 1968 Leland married Faye Ballard of Alturas in Reno, Nevada. He retired in 1975.

His eldest son, Randall, began farming with his father and in 1960 became a partner. He firmly believes that

to be successful in farming "you have to like it and be dedicated."

Randall attended Purdue University in Indiana and in 1944 graduated from Oregon State University in agriculture. That same year he married Virginia June Lee of Chicago, Illinois. He served in the U.S. Navy during World War II.

Lynn Pope is following in his father's footsteps as a dedicated farmer and cattleman. He is a 1967 graduate of Oregon State University in food science and in 1969 received his master's degree in food science at Michigan State University. He became a partner with his father that same year.

Pope Ranches began a performance evaluation program in the fall of 1969 with the weighing of part of the spring calf crop. In 1970 the Popes joined the American Angus Association's American Herd Improvement Record program and have participated ever since.

"Early sire selection, prior to the initiation of performance testing, from the herd of the late Scott Warren at Algoma turned out to be most fortunate," says Lynn. "At that time, performance-proven cattle were very scarce and the type of cattle being promoted did not meet the needs of the market for beef. Those Algoma

cattle were on the right track."

As the program developed the Popes made refinements including testing the rate of gain, testing bulls under feedlot conditions, testing birth weights to evaluate calving ease, and the adoption of artificial insemination in 1973.

The Pathfinder cow and sire recognition program conducted by AAA lists 17 qualifying cows bred by Pope Ranches and one bull, Algoma Bardolieremer 5023, bred by Warren and used extensively by Pope Ranches.

Lynn feels the future is exciting with many opportunities for producing better cattle. He is president of the Klamath Cattlemen's Association and has served on the county fair board.

"The right combination of breeds for each production situation, coupled with performance evaluation, will help counter the popular theory that beef is an inefficient food producer," he says. "Naturally, we feel Angus should be a part of most production situations."


