ADDITIONAL INFORMATION

The farm was founded in 1875 consisting of 160 acres. Apparently part of the farm was sold between 1875 and 1907. In 1907 approximately 100 acres were divided into five parcels of 20 acres each. My mother inherited one parcel, and my mother and father purchased another parcel from my aunt, totaling 40 acres, which has been in the family since 1875.

The other three parcels were sold by family members to different parties, but in subsequent years we have purchased two of the remaining three, therefore we now have 80 acres of the original farm.
