James Davlin left ranch to two daughters--Lilly Davlin and Ada Davlin Nichols.

Ada Nichols was the wife of I. B. Nichols, our father.

During the Com Creek Indian uprising, the people in the area forted up at the original Gage house.

This was a 4 horse stage stop up until 1910.

The Brockway post office was on this farm in 1893 until discontinued in 1956. S. S. Bolsinger served as post office master from 1888 to 1893 when I. B. Wichols took over in 1893.
