

## Snapshot: A reminder of earlier days on the Davidson farm south of Shedd.

Leslie Hoefer, Rt. 2 Box 146.

It was founded in 1877 by Samuel T. Crooks, who left it to his daughter, Rebecca She married Henry Hoefer, They left the farm to Gordon Hoefer, who in turn is the father of Leslie.

Mrs. Hoefer said their original house burned, but they still have a barn which is about 100 years old.

They grow row crops, such as corn, beans, mint and sugar beet seed.

Between Albany and Lyons lies the Century Farm owned by Roy and Marian Goar, 38266 Goar Road, Scio. It was founded in 1881 by Allen Gilkey, who was father of William Gilkey. Mrs. Goar's father

"We live on only a small part of the original farm," Mrs. Goar said. "I had four brothers and during the Great Depression each took a part of the farm to keep us going."

She said her brothers are "all gone" and their farms have been taken by others so the Goar place is the only Century Farm left out of the original claim. Goars raise a field of hay some pasture grass and a few beef cattle.

Mrs. Goar said none of the original buildings are standing.

"One hay barn on a dairy farm run by one of my brothers survived the Columbus Day storm (in 1962) but went down later," she added.
