They immigrated to Illinois in 1884. In the fall of 1893, John Philipp Schifferer came to Iwoner, Oregon from Elgin, Illinois. He arrived by train in Oct. 1893 with his wife Sottliebin and their six children. On December 4, 1893, he purchased the farm I now live and work on, The enclosed copies of documents verify this and the amount he paid for the form. It owever, there is a part in this document, The Warranty Deed, that shows the date 1894, We feel that it wasn't recorded until this date. The information I have told you was heard from my grandfather many times. He has been gone now for many years, but the memory lives on of his story about when they first arrived on the farm on that October day in 1893, Sincerely Jim C. Schifferer
