Frizzell for the consideration of the sum of Eleven Thousand DOLLARS, to him paid, has bargained and sold, and by these presents do bargain, sell and convey unto Albert Domes the following described premises, to-wit: Beginning Eleven and ^{initially} Two Hundredths (11.92) Chain North of the North East Corner of Section No. Twenty (20) in Township Six (6) South of Range Four (4) West of the Willamette Meridian, Thence North two and seven tenths (2.7) chains, Thence West Forty (40) chains, Thence South Forty Eight (48) chains, Thence East Fifty one and ninety two hundredths (51.92) chains, Thence North Eight (8) chains, Thence West Eleven + ninety two hundredths (11.92) chains, Thence North Forty (40) chains to the place of beginning, containing Two hundred (200) Acres more or less, and situated in Polk County and State of Oregon.

To Have and to hold the said premises, with their appurtenances, unto the said Albert Domes his heirs and assigns forever.

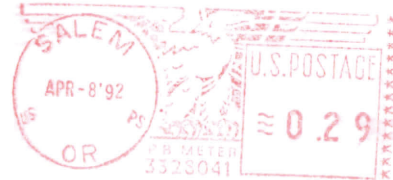
