ADDITIONAL INFORMATION

Bradford Cornelius Trowbridge crossed the plains by oxen team from Dixon, Illinois, to California in 1859. In 1862 he moved to Oregon, arriving in the John Day Valley on July 19, 1962. On July 20, 1962, my father filed on 160 acres of land under the Preemption Act. This was the first ranch taken up in Grant County. Not long after my father filed on this ranch, Mr. I. B. Hazeltine and Mr. W. M. Wilson each filed on 160 acres adjacent to my father's land. Later on my father brought Mr. Wilson's 160 acres and also 120 acres of Mr. Hazeltine's land. The forty acres which Mr. Hazeltine kept is now a part of the City of John Day. My father was approximately 25 years of age when he arrived in the John Day Valley. 
