The property at Redacted for Privacy North Plains, Oregon was purchased by Julius and Caroline Walter on July 5, 1890 from M. J. Wirtz. Julius and Caroline Walter are my great grandparents.

The property was sold to Charles Walter (Grandfather) on September 25, 1895. Charles Walter farmed the property along with operating the Blacksmith shop in the town of Glencoe until about 1910. Charles Walter continued to run the Blacksmith Shop until 1964. Charles Walter's son, Edward Walter started farming at age 14 in 1910 and took over the farming operation. He farmed it alone until his younger brother Albert (Bert) Walter (Father) started farming with him about 1915 or1916. They farmed together on this property with many other farms they leased in the local area. The property was sold to Edward Walter and Bert Walter in the 1960's. Charles Walter retained a life estate in the property.

Donald Walter, son of Bert Walter, started farming in 1954 when he graduated from Hillsboro High School. In 1961 Donald Walter purchased Edward Walter's share of the operation, as he retired, and farmed as a partner of Bert Walter until 1967. When Bert retired, Donald Walter then farmed the whole operation and then purchased the property in 1977. Bert Walter retained a life estate in the property until his death. Donald Walter is still farming the property with some help (part time) from Bruce Walter (son) who lives on the original property.
