

2n 1905 Peter Joseph Bruck a 45 year old batchelor came to Oregon for A from Kentuchy. He feilt a 16x22 one room house. The house had no inselation and only the outside wall. no running water, no electricity, no phone, no public road. Water was 300 feet from house from a spring. travel was by steamship to aregon c.t., by astland on the will amette river, P.J. Bruck died in 1922. J.J. Bruck, Brother of P.J.B. tended the property from his adjoining form. In 1936 J.J. Bruck jr. moved on to the property and built a house and a large (3000 spft.) chicken have for laying hens, he also raised beef cattle.

In 1964 Earl Bruck and wife Jouise sought the farm. We raised cattle, shop and Mogs. We now have a large filbert nurse and christmas trees and a son and grandsons involved with the forming. Sal Bruck
